#### WORKSHOP 1 REFUGEE PARTICIPATION FROM DAY ONE (in English)

#### WORKSHOP 5: VOTING & PARTICIPATION WON'T MAKE ANY DIFFERENCE – RIGHT?

- What kind of measures should be taken to raise awareness of voting and other forms of societal participation and influence among foreign-language speakers and to increase their trust in these?
- Foreign-language speakers are clearly less eager to stand as candidates in political elections
  than speakers of the national languages. The percentage of foreign-language speaking
  candidates who are elected in municipal elections is also clearly lower than that of nationallanguage speakers. Foreign-language speakers and young people in particular are thus left
  without any experience of municipal positions of trust and do not feel at home in political
  associations.
